  - ii) Experience certificate, if any (self-attested photo copies).
  - iii) Date of birth certificate (self-attested photo copy).
  - iv) 07 passport size photographs.
  - v) Medical fitness certificate from any qualified Registered Medical Officer not below the rank of Assistant Surgeon of a Government Hospital/ Shri Mata Vaishno Devi Narayana Superspecialty Hospital, Kakryal (in original).
  - vi) Character Certificate from a Revenue Officer not below the rank of a Tehsildar within whose jurisdiction he / she resides or the Superintendent of Police of the District concerned (in original).

The original copies of documents mentioned at (i), (ii) & (iii) above shall also be required for verification upon joining.
